### **Guard Monitoring System**



A Guard Monitoring Unit (GMU) is a system that is supposed to replace the physical monitoring of the guard. It is electronic equipment which monitors guards' alertness by way of the guard using a device to tap on the machine at pre-set intervals. The machine can be mounted at different locations at the protected area's perimeter ensuring that the guard will patrol all the designated points. This innovation will be offered by Guard-Alert Electronics (GAE) in the near future to enhance security at clients' premises and will greatly improve the monitoring of guards' performance.

The Guard Monitoring system is set up in a way that it is hooked to the GAE control room which will have systems in place to closely monitor the activities of the guards at the guarded premises. The controller at the 24- hour monitored control room will monitor that the guard is tapping the GMU at the prescribed intervals. If the guard does not log in at the given time, the guard will be raised on the radio to check that all is in order at the premises. If there is no response from the guard on site a reaction crew will be despatched immediately to check if anything is amiss, as the guard on site might have been waylaid by thieves.

The client might choose to view the data of the logging in by the guard post the event as a way of monitoring the guard's activity at the premise while away. The information can be downloaded, viewed and assessed at the premises owner's leisure.

The main benefit of the GMU is that the client can monitor the diligence of the guard force stationed at their premise. The fact that the GMUs are stationed at particular locations which are selected for strategic purposes ensures that the points are monitored regularly and this is not left to chance. The guard will remain alert as they know that should they fail to tap the GMU, their actions are recorded and a follow up will be made. The times and routes when the GMU is tapped are also monitored and this information can also be closely monitored. Reports on the guard's activities are generated and this information is important should a review of the current security set up be required.

#### **Hotspots**
